Deductibles and co-pays will be forgiven as allowed by law. If the subscriber submits verification of no insurance coverage, the plan will pay the entire amount **if transport was medically necessary**.

What if I don't subscribe to Leighton Ambulance Association?

Non Subscribers are fully responsible for the entire amount of the ambulance bill not covered by insurance.

Please be assured that **Leighton Ambulance Association** will always respond to an emergency call whether you are a subscriber or not.
